The Commonwealth of the Northern Mariana Islands (CNMI) Judiciary is seeking a highly motivated individual for the position of:

DEPUTY MARSHAL I

On the island of SAIPAN

DUTIES: The successful candidate will work under the Chief Justice and under the direct of the Chief Marshal in the Marshal Service Division on Saipan which involves the enforcement and execution of judicial orders and assigned law enforcement duties. The duties of this position include, but are not limited to the following:

- Performs enforcement and execution of court orders and service documents such as jury summons;
- Performs court security duties required for judicial proceedings, protection of justices, judges, court staff, clients, jurors, witnesses, and judicial facilities; assists in the operation of the court's security control monitoring systems;
- Conducts inspection and screening of all persons entering the courthouse and prohibits the entrance onto the court's premises of any items that are restricted or prohibited; provides the public with direction and information on all public services locations within the courthouse;
- Prepares written reports of service and non-service documents, incidents, and other reports as required;
- Performs prisoner handling while awaiting court hearings; escorts prisoners to courtrooms and to holding cells as directed;
- Has knowledge of and follows courtroom directives;
- Completes annually all required training including firearms; complies to all procedures relative to the proper use, maintenance, and security of government issued firearms; and
- Performs other duties on the courthouse premises as assigned.

QUALIFICATIONS AND REQUIREMENTS: Candidate must have a high school diploma or equivalent, a minimum of two (2) years experience in law enforcement and/or one-year college level education in criminal justice or related field of study. Successful candidate must provide current police and traffic clearances and proof of eligibility to work in the CNMI. Must have a valid drivers' license and operate a court vehicle. Applicants given a conditional offer of employment with the CNMI Judiciary will be required to submit to urinalysis to screen for the illegal use of drugs prior to employment.

COMPENSATION AND TENURE: This is an ungraded position appointed and served at the pleasure of the Chief Justice. The salary will be \$20,000 annually.
