CNMI Judiciary Operations Schedule and Relocation of Offices For Monday, June 25, 2018 Until Further Notice

Effective Monday, June 25, 2018, services of the Judiciary's Accounting Service Unit/Cashier, Commonwealth Recorder's Office, Office of the Clerk of the Superior Court, and Law Revision Commission will be administered at the front exterior of the Guma' Hustisia, where three transaction windows were installed. The public will be able to complete payments, process filings, obtain police clearances, and have access to other services at the walk-up transaction windows. In accordance with the Americans with Disabilities Act ("ADA"), reasonable and appropriate accommodations will be provided to persons with disabilities with the assistance of the Marshals Service Division.

The Guma' Hustisia continues to remain closed to the public, but the Judiciary is making every effort to continue court services in an efficient, professional, and courteous manner.

<i>Court Hearings:</i>	United States District Court for the Northern Mariana Islands, Horiguchi Building in Garapan, Saipan Governor Pedro P. Tenorio Multi-Purpose Center in Susupe, Saipan
<i>Drug Court Division:</i>	Department of Public Safety Training Offices in Susupe, Saipan
<i>Family Court Division:</i>	Department of Public Safety Training Offices in Susupe, Saipan

Office of the Clerk of the Superior Court: Window 2, front exterior of the Guma' Hustisia in Susupe, Saipan (*for clearances and traffic history*)
Window 3, front exterior of the Guma' Hustisia in Susupe, Saipan (*for filings, authentication and certification, mailbox, etc.*)

Law Revision Commission: Window 3, front exterior of the Guma' Hustisia in Susupe, Saipan
